Dear EnTrans International Vendor,

As a valued Partner with EnTrans we want to make you aware of upcoming changes to the current process used to select freight transportation carriers, book freight, and use of the bill of lading. EnTrans International has partnered with Transportation Insight (TI) since 2017 to provide transportation management services for our company. Our partnership with TI is evolving to further assist us with the dynamic changes of our industry, and to allow EnTrans to improve the management of our transportation. From these changes, there will be modifications to the current process used by vendors to select carriers and book freight.

EnTrans' vendors will now use Transportation Insight's Outsourced Execution (OE) team for <u>all LTL and TL freight</u>, where EnTrans International will be the responsible party for transportation costs. This new process will enable you to quickly and easily provide the same shipment information used for the portal to the TI Outsourced Execution team allowing them to create, execute, and track the shipment. After you provide the shipment details, TI will email you the Bill of Lading for the shipment. This BOL is critical to the success of our transportation program and must be used to allow for visibility to track shipments.

This new process will begin for all EnTrans vendors and locations beginning on 06/29/2020, and will replace the current vendor portal.

On the second page, please find the required information to be communicated to the TI OE team for shipment creation.

IMPORTANT Note for Parcel Shipments:

- 1. UPS Parcel should be utilized for shipments if;
 - a. Weight is less than 150 Lbs.
 - b. No one side is greater than 45"
 - c. No one individual item greater than
 - For domestic shipments, a package is considered a "Large Package" when its length (longest side of the package) plus girth [(2x width) + (2x height)] combined exceeds 130 inches
